As a condition of my participation in the Federal Aviation Administration (FAA) Unmanned Aircraft System (UAS) Remote Identification Demonstration (the Event), I acknowledge and agree to the following:

_____. I will not make any video or sound recordings or take any still photographs of the Event.

_____. I will not post information about or otherwise discuss the Event on social media platforms, including but not limited to LinkedIn, Facebook, Instagram, and Twitter.

_____. I acknowledge that the *Remote Identification of Unmanned Aircraft Systems* final rule is under development and that any discussion of the rule must be limited to publicly available information. I will NOT discuss the U.S. government position, deliberations, investigations; and any other activity involved in the regulatory and rulemaking process with any individuals outside of the U.S. government.

_____. I acknowledge that under the Department of Transportation and Federal Aviation Administration rules, any discussion of the rule between a federal employee and any other non-federal attendee, including providing opinions or commentary on what provisions should or should not be in the rule, must be summarized and posted to the *Remote Identification of Unmanned Aircraft Systems* rulemaking docket. I further acknowledge that if the FAA becomes aware that I have engaged in such conversations and I have not submitted a summary, the FAA will submit a summary on my behalf.

_____. I acknowledge that in the course my attendance of any portion of the Event, that I may learn about or may have access to Information. For the purposes of this agreement, the term *Information* is defined as, but not limited to, proprietary information, sensitive unclassified information, and information of a confidential nature belonging to either the United States government or private entities in any medium or format.

_____. I will NOT discuss, divulge, or disclose any Information to any unauthorized person or entity. I will safeguard and prevent the unauthorized disclosure of Information in accordance with all applicable statutes, regulations, and orders. I will return all Information and all copies and reproductions thereof upon request of the FAA. I understand that the unauthorized disclosure, use, or mishandling of Information may adversely affect the owner of the Information, the national interest, and the conduct of federal programs. I understand that federal

and state laws and regulations provide for criminal and civil penalties for improper disclosure, including but not limited to 5 U.S.C. § 552a; 41 U.S.C. §§ 2010-2017; and 18 U.S.C. §§ 641, 1832, and 1905.

____. The restrictions described in this Agreement do not extend to Information that has become generally known or available to the public without breach of this agreement; is disclosed with the prior written approval of the appropriate FAA Official; or (after notification to the appropriate FAA Official) is disclosed pursuant to a statutory requirement, regulatory requirement, or subject to the Order of a competent Court of United States jurisdiction.
